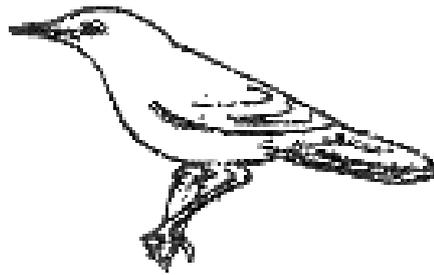

### FESWI VISIT TO MELBOURNE

#### WATER

Philippa Bailey President FESWI

Philippa Bailey, President FESWI and Andrew Silcocks, FESWI member and bird expert, met with Melbourne Water Managing Director Shaun Cox and General Manager David Ryan at MW head office in June.

FESWI initiated the meeting to introduce ourselves and inform the managers about the work that we do and the current priorities facing Edithvale-Seaford Wetlands management and protection.

The managers welcomed on the ground information about current projects, and feedback about the work that Melbourne Water is engaged in at both wetland areas.

FESWI discussed the benefits of the Discovery Centre, and the mutual arrangements with the Melbourne Water education team. The improvement

works at Seaford wetlands and the refurbishing of the central track were noted.

FESWI went on to request that Melbourne Water consider revegetation at the 44 First Avenue, Chelsea Heights site as a priority, once the land is officially handed over to Melbourne Water. (See The Warbler May 2013). We noted the groups' interest in assisting with the revegetation.

The importance of the bird hide at Edithvale was discussed at length with discussion about the Ramsar status and the need for bird lovers and community members to have the close access to wetland habitat that the bird hide has always afforded. Plans were made for Melbourne Water to assist FESWI and concerned bird watchers to review the restoration of the bird hide. A process has started to take shape.

## MIRROR BUSH



**F**rankston Council has been busy recently getting rid of that cursed woody weed – Mirror Bush. It is incredibly invasive, and would completely take over plantations, out-competing the native plants if allowed.

Mirror Bush is a straggly shrub 2-4m high, with round, highly glossy and slightly fleshy leaves. If the plant is growing in a very dry situation the leaves may be rolled almost into a tube to reduce water loss from the leaf surface. Plants are either male or female. Flowers are small and white, followed by small fleshy orange berries on female plants. Cultivars with variegated foliage are sold in nurseries, and these should also be regarded as potentially weedy. The dense shade cast by mirror bush suppresses native vegetation. Dispersal can be by birds and other animals.

If you have it in your garden, serious consideration should be given to its eradication.

# POPULATION OVERLOAD

## *Frankston Housing Strategy Final Draft*

The *Frankston Housing Strategy Final Draft* states that “Between 2011 and 2031, the population of Frankston City is expected to grow by between 27,000 and 40,000.”

The Green Wedge around Stotts Lane is under threat by developers who have applied to rezone the site for housing development.

Local communities are threatened with a loss of amenity and neighbourhood character; and with all manner of problems associated with medium to high density housing.

Why this accommodation of continually increasing numbers? The solution to population expansion is not simply to keep absorbing it into areas already under pressure, to the detriment of all.

If the car park is full, I don't drive in anyway and stack my car on top of another – I either go by train or find another car park. I suggest that Frankston (and indeed Melbourne) is pretty much a full car park!

Urgent and serious attention needs to be given to achieving zero population growth, and in the interim, regional solutions need to be found.



# WETLAND IN MY BACKYARD

I have made many visits to my family property near the Otways National Park, over the past 30 years, during winter months. Part of the paddock area always floods in years of standard rainfall, and it has been a family priority to visit the “pond” as it was fondly named.

Over the years I have enjoyed watching yellow robins, blue wrens, kookaburras, soaring eagles and other hunting birds. However I had never thought of the winter pond as an ephemeral wetland, until a few weeks ago, when I came across a white-necked heron taking off in flight as I approached the pond.

I was thrilled! A wetland bird in my own back yard! I cautiously monitored the heron over the weekend and it seemed to be nesting on its own near the edge of the pond. That was the area that it took off from at my stealthy approach. It circled overhead for a while but did not return to the pond until the nosy human had moved well away.

White-necked herons are found near farm dams and winter ponds, feeding in shallow waters and wet grass. They nest in trees. One report that I read of the bird noted that they are often on their own. I had wondered about a mate for

my heron, so I am assuming that at this stage he or she is single!

I hope to see the heron again on my visit to the property later this month.


As chair of *Frankston Environmental Friends Network*, David Cross said, "We are opposed because of the significant loss we, as a city, have had of the natural environment over recent years – the Peninsula Link development, rezoning of Peninsula Private Hospital land and loss of land at the Pines Flora and Fauna Reserve."

He also said that there was also concern over the loss of rural land and a habitat corridor.

An application has been submitted to Frankston Council to rezone the site.
